Experience Summary

Brief Overview:

In 1994, when I was 42 years old, I was sexually assaulted by a stranger in a parking garage in downtown Portland, Oregon. I was leaving work late and walking to my car when the attack occurred. I immediately reported the crime to police and went to the hospital for examination, cooperating fully with the investigation. Despite my efforts to work with law enforcement, the case quickly stalled due to lack of physical evidence and witnesses.

The detective assigned to my case left the department six months later, and no one took over the investigation. Over the years, I've made multiple attempts to follow up, but the case remains officially open yet inactive. I've kept detailed records of all my interactions with police and medical professionals from that time. Now in my 70s, I'm still seeking acknowledgment and some form of closure for what happened to me thirty years ago.

Key Elements:

- Attack occurred in a workplace parking garage during evening hours, highlighting workplace safety concerns
- Case was never properly transferred when the assigned detective left the department, resulting in investigative abandonment
- Assault happened in 1994, before DNA databases and modern forensic techniques were widely available
- I maintained detailed personal documentation of all interactions with authorities over three decades
- Despite immediate reporting and full cooperation, the case exemplifies systemic failures in stranger assault investigations

Systemic Issues:

The most significant failure was the complete breakdown in case continuity when my detective left the department. There was no formal handoff process, no supervisor follow-up, and no notification to me that the case had essentially been abandoned. The police department had no centralized case management system, so my file just sat in a drawer. When I called for updates, desk officers would often tell me they couldn't locate my case number or that someone would get back to me – but no one ever did. The district attorney's office was similarly unhelpful, saying they couldn't pursue a case with no active police investigation. This created a bureaucratic dead end where each institution pointed to the other as responsible, leaving me completely without recourse or even basic communication about my case status.

Timeline of Key Events:

- March 15, 1994: Assault occurs in downtown Portland parking garage; I immediately report to police and go to hospital
- March 16-30, 1994: Initial police investigation begins; detective interviews me twice and canvasses area for witnesses
- April-August 1994: Investigation stalls with no leads; detective becomes increasingly unresponsive to my calls
- September 1994: Assigned detective leaves police department; no case transfer or notification provided to me
- 1995-1999: Multiple attempts to contact police result in confusion about case status and location of files
- 2000-2010: Periodic follow-ups with police and DA's office yield no progress; case remains officially open but inactive
- 2011-2020: Limited contact with authorities; focus shifts to personal healing and documentation of experience
- 2021-Present: Renewed efforts to seek acknowledgment and closure; researching legal options and victim advocacy resources

Details and Context

Offender Description (optional):

The perpetrator was a white male, approximately 30-35 years old, about 5 feet tall with a medium build and dark hair. He appeared to be familiar with the building layout, suggesting he

may have worked in the area or had prior access to the parking garage. The attack seemed planned rather than opportunistic, as he waited in a concealed location and knew the garage's blind spots.

Perpetrator Pattern:

Potential serial offender, Other pattern

Method or Approach:

He was hiding behind a concrete pillar near my car when I approached. As I unlocked my door, he grabbed me from behind and forced me to the ground between parked cars. He seemed to know exactly where the security cameras couldn't see and had clearly been watching my routine – he knew which car was mine and what time I usually left work.

Possible Connections:

Likely so

Evidence Status:

Official police reports, Medical records, Physical evidence

Institutional Response:

My employer initially offered to pay for counseling but became defensive when I suggested improving garage security, claiming it would be too expensive. Law enforcement, as described, completely failed in case management after the detective left. The hospital was professional during the examination but provided no follow-up support or victim advocacy resources.

Impact and Outcomes

Current Status:

The case remains officially open but inactive with the Portland Police Dept. I last contacted them in 2023 and was told the file still exists but no detective is assigned. The statute of limitations has long expired for prosecution, but I continue to seek acknowledgment of what happened and hope that advances in forensic technology might eventually provide new leads. I'm currently exploring victim advocacy resources and considering requesting a formal case review to document the institutional failures that occurred.

Broader Implications:

My experience reveals how institutional failures compound to create a perfect storm of abandonment for survivors. The lack of proper case management protocols, inadequate interagency communication, and absence of victim advocacy infrastructure in the 1990s created a system where cases could simply disappear without accountability. This pattern likely affected countless other survivors, particularly those without the resources or persistence to repeatedly advocate for themselves. The broader issue is that criminal justice systems often measure success by conviction rates rather than by how they serve survivors, leading to neglect of difficult cases that lack immediate prospects for prosecution.
